

MINUTES OF THE COURT FO THE APPEAL About Stewards decision No. 4 from "ENEOS Riga Summer Race" on 18-20.08.2017.

17th of October 2017

The Court of the Appeal of LAF on 11th of October in Riga, at 18:00 revised Appeal received from the competitor VŠI "Petrovo motorspotas"Licence No. MEM/75 in following composition:

The Court of the Appeal according to LAF Sporting Code 12th Article 3rd chapter decided following:

- After examining Appeal claim, the Court of the Appeal finds out that Article 12.21.2.of LAF Sporting code is not respected. Article 12.21.4. of LAF Sporting Code is not respected.
- Applicant did not use his rights to give Protest during the competition "ENENOS Riga Summer Race" 18.-20.08.2017 as it is set in the Article 11.7.4. of LAF Sporting Code.
- Based on Article 12.39.of LAF Sporting Code, LAF Court of the Appeal revised this case in substance. After investigating all the documents from this competition and hearing officials of the competition, the Court of the Appeal could not obtain objective evidence of the conduct of the final technical checks and the facts found, as well as the car's compliance with the technical regulations. In addition, there is non-compliance in the competition documentation as well as in the behaviour of official persons.
- Based on all of the above, the Court of Appeal dismisses the Appeal and upholds the Commissioners Decision No. 4. In case that the Appellant fails to apply the FIA International Court of Appeal, the overall of the Championship for that class shall be calculated according to this decision.
 - The appeal fee paid shall be returned in full amount EUR 1000,- to the appellant. ASN Board will be informed about the non compliance of the official persons and organizer of the "ENEOS Riga Summer Race" with assigned positions and duties. The appointment of LAF observer and Steward for Latvian Championship competitions organized by the LAF Racing Commission will be requested.

In accordance with Article 12.32.of LAF Sporting code, this decision of the LAF Court of Appeal enters into legal force at the time of its adoption on October 17, 2017. The decision of the LAF Court of Appeal is subject to appeal to the FIA International Court of Appeal, in accordance with the FIA Sporting Code.
