



LAF Rally Commission's Decision (translation)

No 3/2020

October 30, 2020.

**According to the LAF rally commission's decision No.2 on October 30, 2020 due to the COVID-19 restrictions, the commission's decision is to cancel the 4<sup>th</sup> round of the Latvian Rally Championship "Saremaa Rally 2020" and according to appendix 1.7.1 of the Regulations of 2020 Latvian Rally Championship "(.) *Latvian rally champion's title in each support category is decided, if during the season there a minimum of 8 crew entries, minimum of 4 rounds, and at each round, there are minimum of 4 crews participating in its support category. If any of the rules aren't met, this category turns into a cup contest.*"**

LAF rally commission council decides:

- 1.1 To approve an official championship status in 2020 season only to LRC- ABS group.
- 1.2 Due to the COVID-19 restrictions and the cancellation of 4<sup>th</sup> round of the Latvian Rally Championship, the LRC title for each support category in 2020 season is calculated based on 3 rounds, and decision to be approved in LAF presidium.
- 1.3 To arrange a cup contest for all participants in 2020 season according to appendix 1.7.1. of the Regulations of 2020 Latvian Rally Championship, except LRC & ABS group participants.
- 1.4 According to the cancellation of the final round of the Latvian Rally Championship, double championship points from the prior rounds won't be counted in 2020 season.
- 1.5 According to the cancellation of the final round of the Latvian Rally Championship the A.Karamisevs award won't be awarded in 2020 season.
- 1.6 To approve the current results after 3 rounds (in the attachment) as the final ones for the 2020 season.
- 1.7. To reconsider the possibility of the award ceremony for 2020 season to be held, due to the emergency status in the State, the final decision will be decided until 15<sup>th</sup> December, 2020.

**According to LAF rally commission's decision No.1 on 08<sup>th</sup> September, 2020. Due to possible COVID-19 restrictions, therefore, the 3<sup>rd</sup> round of LAF ralliesprint and historic cup "Rally Elektrenai 2020" is been cancelled.**

LAF rally commission council decides:

- 2.1 To approve LAF ralliesprint and historic cup competition based on 2 rounds.
- 2.2 According to the cancellation of the final round, double championship points from the prior rounds won't be counted in 2020 season.
- 2.3 To approve the current results after 2 rounds (in the attachment) as the final ones for the 2020 season.
- 2.4 To reconsider the possibility of the award ceremony for 2020 season to be held, due to the emergency status in the State, the final decision will be decided until 15<sup>th</sup> December, 2020.
