I. INTRODUCTION

4.2 Only individuals with submitted entry form, paid fixed entry fee and having legitimate driving licences (first driver and co-driver) are allowed to participate in the competition. LARSC participants (first driver and co-driver) must have valid “E, D, DJ” categories licences issued by LASF or any other ASN. LARSC classifications’ participants (first drivers) must be of at least 16 years old. Co-drivers must be of at least 14 years old. If LARSC competitions’ participant (1st driver) is younger than 18 years old, he or she can participate with only two-wheel drive vehicle that engine capacity is within 2000 cm³. If the participant does not correspond this requirement, the participant is allowed to participate in LARSC competition only with protocolled decision of the Rally committee. LARSC participants must submit the LASF entry form of the championship.

4.3 Correctly and fully filled entry form that is published in www.akselelatorius.eu, www.lasf.lt, www.laf.lv must be provided to an Organizer according to the terms and dates listed in 4.1 article of these Supplementary Regulations. The entry form is considered to be submitted when the Organizer confirms it and the entry fee is paid. The data about the Co-driver can be provided during the Administrative Checks.

4.3.1 Correctly and fully filled and **signed** original entry form must be presented during Administrative Checks. By signing the entry form, the participant confirms that all the information of the entry form is true and correct.

4.3.2 These crews that are willing to receive more convenient administrative and scrutineering times, must to indicate that in the entry form submitting it until 23-07-2019.

4.7 Partial refund of the entry fee.

If a crew with submitted entry cannot participate in a competition because of justifiable reasons, it might get a 50 percent refund of the paid entry fee. If the competition is cancelled due to “Force Majeure” circumstances, participants with submitted entries are refunded with 50 percent of paid entry fee. If Organizer rejects the entry of a crew, full entry fee paid is refunded.

4.8 Rally “0” crews have to pay 150 Euro deposit until 26-07-2019 (Friday) 18:30 h Inclusive. It is returned in case of crew fulfilling all tasks and functions of “0” that have been assigned by Organizer. It is valued according to Clerk of the Course report.

4.9 Restricted areas

4.9.1 All 1st drivers and Co-drivers planning to participate in 2019 “**AROUND SEVEN LAKES RALLY-ZARASAI**” rally-sprint competition are not allowed to be in restricted roads (local zones) from 04-07-2019 23:55 h until 26-07-2019 13:00 h. In restricted areas by rally officials noticed participants are going to be penalized with penalties according to Rally committee decision. The fines and penalties are assigned corresponding to LASC section 12. Map of restricted areas is published from 04-07-2019 (Appendix No. 4) in www.akseleratorius.eu .

4.9.2 Individuals mentioned in 4.9.1 article that are willing to pass through the restricted areas or to stay in the territory must in advance inform the Organizer and LASF and to receive the permission. Organizers' contact phone no.: +370 (614) 35442.

V. INSURANCE

5.1 Each participant must have a valid civil insurance (green card) of the car used for competition, for both, recce and rally cars.

5.2 Organizer insures the participants of the competition with a civil responsibility insurance and it is legally active during the participants drive in special stages from the start to finish or until the crews is forced to leave the competition due to technical reasons or elimination from competition moment. Insurance is valid from the Test special stage. Participants of the competition are not considered to be third parties to each other.

5.3 Rally Insurance police does not hold legal rights for service and recce cars even if they are marked with special markings provided by organizer. Insurance does not cover the drive in between the special stages, during reconnaissance: both times participants must follow and obey the Traffic Regulations of Republic of Lithuania and when they personally are responsible for their actions.

5.4 In case of damage made to third parties, participants must inform the Competitors' Relations Officer until the end of rally. Ignoring this regulation ensures the fine of 100 EUR for each case happening. After the end of the competition, the fine is assigned by Lithuanian ASN according Organizers' writing announcement.

VI. ADVERTISING AND CAR IDENTIFICATION NUMBERS

6.1 Drivers' names and surnames, starting numbers or LASF and Organizers' Advertising items listed in 2017 year LARSC Regulations' Appendix No. 1 and as Appendix no. 3 to these Supplementary regulations referred as "Position of rally stickers and advertising" are mandatory.

6.2. Losing or removing starting numbers, rally and advertising stickers. During the competition, if in 6.1 mentioned stickers are lost, crew must inform the Competitors' Relations Officer until closest service zone stage or by the end of rally, if there is no service zone planed according to the Itinerary. Bypassing doing that or deliberately removing stickers during the competition, the crew is penalized or eliminated from competition according to decision of Stewards.

VII. TIRES

7.1 During the reconnaissance, crews are allowed to use the tires certified by European Union, intended to be used summer time in public roads, corresponding the requirements of Road Transportation Law of Republic of Lithuania.

7.2 During the competition, only sporting gravel tires are allowed to be used.

VIII. FUEL

8.1. Refuelling is allowed only in refuel zones. (T-2017, 58.1.1 article).

8.2. All sporting cars of the competitors using E85 fuel (Bioethanol) must be marked with special stickers (minimal dimensions: 160x120 mm), having white inscription in a blue background. Height of a letter and numbers: 80 mm; the width of the letter' and numbers' line: 14 mm. Stickers should be placed on a body of a car, both sides, above the rear wheel arch within 200 mm from the top point of the arch. (Appendix No. 5)
Without this marking crew is not allowed to participate.

IX. RECONNAISSANCE

9.1 Reconnaissance is mandatory to each crew. Reconnaissance of a Test Special Stage is performed only by the crews that are going to drive it.

9.2 Officials of the rally are published in a Notice Board and in websites www.akseleratorius.eu and www.lasf.lt.

9.3 Reconnaissance is scheduled from 27-07-2019-07-25 (Friday) 11:30 h until 21:00 h. Reconnaissance of a Special stage is planed from 11:30 h until 15:45 h.

All special stages can be run twice. The number of runs is control with a help of GPS system (if it is going to be used).

9.4 During the reconnaissance, the crew must drive without making any danger or troubles to the habitants situated close to the special stages. We are reminding, that according Lithuanian Republic Road traffic regulations, in roads of non-residency and in the roads with non-asphalt surface the speed limit is 70 km/h. In the segments where the road work is done, strictly prohibited to drive opposite direction. During the reconnaissance, rally officials and police officers will control the speed of competitors that cannot exceed the norms of Republic of Lithuania Traffic regulations. It might be reduced using special signs.

9.5 During the Reconnaissance, Competitors must follow these Supplementary Regulations, T-2018, LARSC Regulations and its' Appendixes as well as the Traffic Law of Republic of Lithuania.

NOTE: The speed limit exceed within 10 km/h during the reconnaissance is not considered as violation and penalties are not going to be assigned.

9.6 Cars of the Reconnaissance. It is allowed to use cars registered during the administrative check. Cars should satisfy the regulations of 25.1 article (T-2018). During road books the representative of competitor crew member must provide all the details about cars used for recce along with information about service cars.

9.7 All fines that have been assigned during administrative checks and scrutineering made in a process of recce, should be paid until 27-07-2019 9:30 h.

11.1.1 Priority for crews participating in Shakedown.

11.2 During the Scrutineering before rally start Competitors representative or crew members must present the following valid documents:

- the civil rights insurance policy of the car owner or “green card”
- car registration documents/ certificate;
- MOT pass document;
- sporting car passport issued by LASF or any other country ASN;
- fully filled used fuel declaration;
- crews participating in international FIA “A”, “N”, “R” and “Super 2000” groups: car confirmation – homologation form and any other Appendixes to it. Participating in national “SG” group – manufacturer or car maker representative description.

11.3 Start numbers along with LASF and organizer’s compulsory advertising items that are provided together with the road books according to official list of documents provided, crew must place on the car before the Scrutineering. It is possible to collect the start numbers and advertising stickers before the administrative checks by agreeing with Organizer.

11.4 During the Scrutineering before start the checks of helmets and other equipment of both crew members shall be performed. It can be performed at any other time by rally officials with identifying markings during all rally, in service park, park fermé or any areas equal to mentioned previously.

11.5 For LARSC Participants FHR (“Frontal Head Restraints”) are mandatory.

12.3 In advance registration without receiving penalty allowed in TC 4B, 8A.

12.4 GPS Safety and control system. Crews’ safety in special stages is assured by using GPS safety and control devices.

12.4.1 Issue/collection and usage order of safety and control device. Assuring the safety, emergency announcement, receiving and the follow of competitions’ regulations, together with road books crews are going to be provided with satellite communication GPS safety and control devices. It is mandatory to use it

during reconnaissance and during all the competition. Each crew has to pay 200 euro deposit for a device and is responsible for the device materially.

The device shall be returned in Rally Headquarters until 27-07-2019 21:00 h. If returned device is damaged and not working or if the device is not returned until the time required, deposit is not going to be refunded. It is allowed to dismount the device in Park Fermé after rally finish.

12.4.2 Usage of safety and control device. The same device must be used during Reconnaissance and during competition. The device in a sporting car must be mounted (including informative sticker) according to scheme provided until the rally start. If crew participates in test special stage, it must be mounted before starting in it. Crew is fully responsible for mounting of the safety and control device.

12.4.3 Operation of safety and control device. GPS Safety and control system is directly connected to monitoring station collecting all information. System has an autonomic supply assuring the functioning of the devices system during all the competition. Each device has a unique series number that is assigned to a crew. Crews' geographic dislocation is monitored during the reconnaissance and during all the competition in Rally Headquarters. **Attention!** The device can make some radio magnetic disturbances, typical to GSM technologies. We recommend all the devices sensitive to these disturbances to mount maximally far from the device provided by Organizer.

12.4.4 "SOS"/"OK" message sending order. For "SOS" and "OK" message order violation, crews are penalized according to LASC article no. 12.

12.4.5 Any crews' actions to damp or influence the operation of GPS safety and control system signals or functioning during the reconnaissance or during the competition, will be announced to board of stewards. Stewards are going to assign the penalties and make the decision about elimination from the competition.

12.5 Withdrawn crews must inform the Rally Headquarters by phone, calling the Clerk of the Course +370 614 81141 and informing about the reasons of withdrawal, location and time. Also, the crew has to return the time control card in a closest time control post or to the officials opening the special stage after its' finish. The crew must take of the starting numbers. For violation of this regulation crew shall be penalized with 50 euro fine.

12.6 If the crew is involved in an accident with a spectator or crew member suffering physical injuries, crew members must inform showing "SOS" sign to at least three crews passing through and rally headquarters or Clerk of the Course by calling the contact phone. For violation of "OK/SOS" signs regulations the penalties are assigned according to LASC article no. 12.

12.7 Red flag. It might be shown only in marshals' connection post, that is marked according to indications listed. Passing through the first red flag shown, the crew must immediately reduce the speed and stop further acting according to marshals' instructions. Flags shall be shown in all connection posts ahead of an accident location. Violation of this regulation results the penalty assigned by Stewards according to LASC article no. 12. Crew that was shown the red flag to, shall receive time assigned according to T-2017 39 article.

12.8 All cars must have a red light-reflecting triangle that must be used if car stops due to an accident or technical reason in a special stage. It is mandatory to use the triangle if the car stops on a road or within 3 meters of its' limits. It has to be placed in a visible place on that side of the road where the car is at least 100 meters ahead of the car in order to warn other participants.

12.9 If a crew withdraw the competition due to an accident, crew members or team representative must inform the chief scrutineer about it. Upon his request, the crew must present the car for technical check.

12.10 Service.

Place: Zarasai district municipality, Sėliu sq., Zarasai

GPS: 55.73185, 26.24678

12.10.1 During the rally, sporting cars service procedures are allowed only in service park. Refuel is allowed only in special zones indicated in a road book.

12.10.2 Only **one service car without trailer** is allowed to service park. Sticker provided by Organizer has to be placed on a front window of the car. For violation of this regulation there is a fine assigned. Recce cars and cars of team representatives are not allowed to enter the service park.

Trailers have to be left in a location provided by organizer.

12.10.3 In a service park it is strictly prohibited to wash any car parts or units, that are using technical oils (engines, gear boxes, redactors, shock-absorbers).

12.10.4 Under the sportive car, in a service zone, service park areas there must be water resistant planking placed (minimal dimensions: 4x4 m). In a refuelling zone, there must be receptacle for spilled fuels collection placed under the fuels' tank opening. In case of pumps being used, both ends of a hose must have safety valves.

12.10.5 Each crew receives the service zone of a size up to 50 m². Upon request of a bigger zone, it might be reserved after filling in the order form (Service park zones dislocation), (Appendix No. 6). It is published in www.akseleratorius.eu. Places shall be reserved to those crews who have presented the special order form. Beginning of reservation: 04-07-2019, end of reservation: 23-07-2019 15:00 h. After this term, Organizer shall assign the service zones upon its decision. The scheme of the service park along with reservation details – Appendix No. 6.

12.11 Starting procedure in special stages.

Start in all special stages is performed with electronic equipment. Upon 30 seconds left until start, crew is provided with a time control card, electronic watch displays hours, minutes and seconds. When only five seconds left until the start, the 5 red lights are turning on second by second. The crew must start when they go off. If a start is correct, the green light turns on and stays for 20 seconds. If it is false start – screen displays "FALSE" and the time of too early start is displayed. If there is no electronic equipment or if it is not working properly, starting procedure is performed according to T-2017 37.3 article regulations. Start marshal has to inform the crew if the starting procedure is going to be performed without electronic equipment.

12.12 Regrouping. One regrouping is going to be during the rally. It is going to happen after 2nd section, according to results of SS 1-4.

12.13 Test special stage is going to be organized on 26-07-2019 from **17:00** until **20:00 h**.

12.13.1 Those who are willing to participate in a Test special stage must to indicate that in a electronic entry form. It has to reach the organizer until 23-07-2019 16:00 h.

12.13.2 The entry fee of the special stage is 80 Eu. It has to be paid until 26-07-2019 16:00 h.

12.13.3 The length of a Test special stage – 3,65 km. It is allowed to run this SS within 5 times.

12.13.4 For Test SS participants the scrutineering must be performed in advance. All cars must have on all the stickers and starting numbers provided by Organizer.

12.13.5 During Testing SS, any individual sitting in a sporting car acting as a co-driver, who is not registered as a participant of the competition, must sign the form of full responsibility provided by Organizer. During Testing SS, all the individuals participating must wear the helmets, clothing and safety equipment required by the regulations.

During the Testing SS, all service procedures and refuel shall be performed only in special areas indicated by Organizer. It is going to be marked in a road book. The surface of a service zone – asphalt. The crew whose car has suffered an accident during the Testing SS, has to inform the Chief Scrutineer. Upon his demand, car has to be presented for additional technical checks.

12.14 After testing SS, rally cars can be washed at: Zarasai, Statybininkų st. 2. GPS coordinates: 55.7175, 26.2490


