## **MEMORANDUM**

Of Rallycross Championship Latvia - Lithuania















Date: 6<sup>nd</sup> of May, 2022

**Latvian Automobile Federation**, a limited liability company, existing and operating under the laws of the Republic of Latvia, as the Member of FIA, hereinafter LAF, represented by its president Raimonds Kisiels and

**Lithuanian Automobile Sport Federation**, a limited liability company, existing and operating under the laws of the Republic of Lithuania, as the Member of FIA, hereinafter LASF, represented by its president Egidijus Janavičius

Whereas the rights to conclude this agreement is grounded by the strategic decision of the off-road commissions of Latvian and Lithuanian ASNs here with individually referred to as a ASN and collectively as a ASNs, agrees on the following:

- 1. To establish unified rallycross series: Latvian Lithuanian Rallycross Championship (further on LRX).
- 2. By establishing this championship, the LRX to become a major platform to develop the national rallycross championships or cup series.
- 3. The Board of LRX will consist of total 4 (four) members, and any 3 (three) out of 4 (four), can make decisions related to LRX.
- 4. Each ASN has to nominate 2 (two) Board members of the LRX for a period of 2 (two) years.
- 5. Nominated LRX Board members: Kazimieras Gudžiūnas (LTU), Arvydas Galinis (LTU), Jānis Bergs (LAT), Māris Breicis (LAT).
- 6. The responsibility and obligations of the promoter:
  - a. To set up the annual rallycross calendar which consists of minimum 4 (four) rounds in the said territory, Latvian Lithuanian Rallycross championship, unless it is not possible due to any force majeure circumstances including pandemic lockdown or governmental decisions.
  - b. To set up all the Sporting and Technical Regulations of rallycross series and rallycross classes.
  - c. To organize (and/or to agree with other rallycross event organizers) the LRX events in accordance with the safety and quality requirements set by the Board of LRX.
  - d. To ensure the proper calculation of the points and determination of the Champions or Cup holders according to the conditions set in the Sporting Regulations of rallycross series.
  - e. To organize the annual gala events where the prize giving ceremony of the Champions must be held. Each ASN pays for the Cups of their licensed awardees. If awardee is not from Latvia or Lithuania Cup expenses will be covered by the promoter.
  - f. To ensure that the races are being supervised by the international Stewards jury minimum 2 (two) Stewards, one from each country (Latvia, Lithuania).
  - g. To ensure that every LRX round is being organized in accordance with the conditions and approval of the both ASNs.
  - h. To provide online registration and official LRX website www.rallycross.lv.
  - To design and produce Cups for each race. Cups will be paid by each LRX round organizer.
  - j. To provide TV broadcast for every LRX round. TV broadcast will be paid by each LRX round organizer.
  - k. To provide official stickers, start sign "READY TO RACE", championship branding banners to each LRX round organizer.
  - I. To provide Race Guide template for each LRX round organizer.
  - m. Provide Press officer. Press officer expenses will be covered by each LRX round organizer.
  - n. Provide each LRX round organizer with official LRX social media accounts.
- 7. Translation to native language of official documents, press releases, etc. will be done ASNs.
- 8. Protests (if any) must be dealt by the Stewards jury of the respective round, however the appeals must be dealt in accordance with the sporting code of each local ASN where the respective round is being held.









- 9. The promoter has the right to conclude any sponsorship agreement which might help to promote LRX during its nomination period however the ASNs have no rights to claim any reward for that.
- 10. Sporting and Technical Regulations must be approved by both ASNs, however the Supplementary Regulations of each round must be signed by the promoter and the legal representative of each local ASN where the round is being held.
- 11. By concluding this Memorandum, it is agreed by the ASNs that the promoter of LRX for the seasons 2022 and 2023 (included) is being granted to:

- 12. Neither any of ASNs have the right to approve organization of LRX events to any other party without written approval of LRX Board. ASNs have no right to approve any rallycross event with the status of Latvian Lithuanian, Latvian or Lithuanian Rallycross Championship unless it is approved by the LRX Board. All rights are in the hands of legal owners of LRX ASNs, making all decisions via board members.
- 13. Adding or excluding by ASNs any of the non-LRX rallycross series which may cause a significant effect towards LRX development can be done only with the written approval of the LRX Board. All rights are in the hands of legal owners of LRX ASNs, making decisions via board members.
